#### **History and Objectives:**

For historical, economic and political reasons, the universities of BRICS countries have not yet developed strong collaboration. Trying to cover this gap, the Ministries of Education of BRICS countries implemented in 2015 the BRICS Network University (BRICS NU).

Involving some of the top universities in the five BRICS countries, the objectives of this network are:

- in the short term, enhance the academic collaboration between universities of the five countries through joint-researches and mobility of students and scholars;
- in the middle-term, create joint Graduate programs issuing diplomas that will be valid for the five countries, and prepare high-qualified staff for the BRICS multilateral institutions;
- in the long-term, enhance scientific development according to the necessities of non-central countries; in this sense, it may give a contribution for "reshaping the world knowledge".

BRICS NU is organized in six strategic axes: BRICS studies; Computer science and informational security; Ecology and climate change; Economics; Energy; and Water resources and pollution treatment (<u>https://nu-brics.ru</u>).

Unicamp takes part in the axes *Ecomomics* and *BRICS studies*. Since the presidency of BRICS this year is Brazilian, the University of Campinas – with the support of its Rector and its International Office – will hold a *BRICS NU Meeting* in the axe of Economics, from August 5<sup>th</sup> to 9<sup>th</sup>, 2019.
